4. APPROVAL OF THE 2021-2022 ACT 1 INDEX RESOLUTION

Dr. Melber explained the resolution states the district will not go above the Act 1 index, which is 3%. At 3%, the district could raise taxes .9546 mils, which would bring in an additional \$2,031,360.00 based on current assessment values, and the district does not qualify for any of the exceptions. Ms. Reed clarified that the resolution does not mean the district will raise taxes 3%, only that they will not go above 3%. The committee agreed to recommend approval to the full Board.

1. BOND REFINANCE OPPORTUNITY

Ms. Doyle addressed the committee regarding the 2016 bonds, explaining that this is a two-step refinancing plan to take advantage of lower interest rates.

Step 1 – Refunding of 2016 bonds – \$784,000 net savings to the district, or 8.28%, conservatively;

Step 2 – Refunding of 2016A bonds – \$90,000 net savings, or 1.55%. The committee agreed to discuss further at the Workshop meeting.
