3. OCCUPATIONAL TAX

Dr. Melber updated the committee that the Pennsylvania Association of School Business Officers (PASBO) is creating a draft amendment to Act 24. If passed, the amendment would allow the use of the fiscal year's Occupation Tax collection data immediately preceding the date of referendum, instead of the 2008-2009 fiscal numbers.

The Finance Committee voted to wait to make any changes to the Occupational Tax to see if PASBO is successful in passing the amendment in the PA Legislature.
