 - 2023-2024 Initial Budget Presentation including Act 1 Resolution Dr. Jeremy Melber (Voting item for January 23, 2023)
 - Dr. Melber noted that any tax increase would not be above the Act 1 Index. By passing this resolution, the Board will be required to keep any budgetary increase to be equal to or less than the Act 1 Index of 4.1%. Dr. Melber stated his confidence in being able to keep the increase to below the Act 1 Index. Dr. Melber will be meeting with the Department Heads next week to review budgetary needs. He will have an update for the Board at the February 27th Board meeting.
