In kind contributions will be considered to offset usage fees. Must be approved by District Administration.

Non-profit community groups whose membership consists of less than 75% PASD residents, who offer cultural programs to the community (such as Chesco Pops or Chester County Night School) may have the usage fee waived if deemed appropriate by the District Administration. Custodian and Tech Support fees will not be waived.

- **Class I –School Related Groups and Organizations**
 - School groups, teams, events
 - Classroom activities
 - Activities sponsored and supervised by school administrative and/or professional personnel
- **Class II –Related School Activities—Class II users shall be responsible for custodial and/or other costs incurred outside of the normal work schedules**
 - School sponsored groups, clubs and student organizations
 - Home and School activities, Booster Clubs
- **Class III –Non-Profit Community Groups**
 - Non-profit groups whose membership consists of a minimum of 75% PASD residents, and NOT charging admission to the event
 - Non-profit groups serving a nationally recognized charity
- **Class IV –Other Community Groups charging admission or taking collection**
 - Non-profit groups charging admission to the event
 - Non-profit groups whose membership consists of less than 75% PASD residents
 - Political meetings or organizations which take collections (including church services, commercial companies, homeowner’s associations)
- **Class V –Outside and For-Profit Groups**
 - All for-profit groups serving our students or community
 - All groups, not in Classes I-IV, charging an entrance fee or tuition, sports camps, dance recitals, etc.
